I oppose the Plan Change in its current proposal and categorise my concerns below.

I support Federated Farmers in there submission and state that:

1. The rules as proposed will impact on my business creating a further \$53,000 in compliance cost
2. Cultivation clauses re: set back and consent to grow and cultivate seasonal stock fodder crops
3. The use of nitrogen and its allocation
4. E.coli levels are an uncontrollable issue due to wild bird population
5. Prevents land from being used for alternative agricultural use
6. No reference made for the removal of exotic and introduced weed or plant life
7. No recognition of the introduction of Koi Carp and its impact on sediment
8. No recognition of the serious storm water /waste water management and urban runoff
9. No recognition of the past establishment of rubbish dumps on the Waikato River and current ongoing leachate issues
10. What defines as swimmable river
11. Is the nutrient discharge likely to become a quota like fishing for Iwi
12. The allocation of nutrient discharge can be classed as a wealth allocation
13. It restricts in total any future production increase – no flexibility in farming operation and the ability to continue developing the farms potential
